

Practicing what they preach? When it comes to their investments, our new analysis finds many faith groups have room for improvement

We are delighted to share our new report, <u>'Good Intentions: What faiths say about how they invest – and how they can do more</u>', which is the first major in-depth, multi-faith analysis of faiths' publicly available statements about their investment policies.

It found that while many faith groups profess a faith component in their investments, this practice is by no means universal, and of those that do, the extent of the alignment varies widely. For example, the study found:



 Of 164 publicly available statements considered, only 42 contained sufficient detail for an

assessment to be undertaken.

- Of these: 69% indicated that faith
 values have a clearly stated role in
 the principles and guidelines that
 govern their financial assets (the Yes
 Group), while 31% made no mention
 of their faith (the No Group).
- Of the Yes group: Only two
 organisations had clearly
 documented that they had
 extensively integrated faith values
 throughout the entirety of their
 investments.
- On average this group's score was just 5.4 on our 10-point scale, indicating that better alignment is achievable for many.



Mathew Jensen, author of the study and a member of FaithInvest's Investment Solutions team (left), says:
"Investment policy and guidelines (IPG) statements are the essential guiding principles and prescriptions for how faith-based investment portfolios are managed. Turns out, faith-aligned IPG statements are more a rarity among faith-based asset owners than one might expect."

While many of the faith organisations we studied in depth mention pursuing faith consistency, and some have done much to move toward full alignment, many others have a long way to go, he adds.

Launch of the Laudato Si' Investor Hub

We are very proud to be launching the Laudato Si' Investor Hub during our May 26 Global Investment Forum event in Ireland. The Hub is a partnership between FaithInvest and the Laudato Si' Action Platform, which is a collaboration between the Vatican, Catholic organisations and all 'men and women of goodwill'.



The Action Platform is inspired by Pope Francis' ground-breaking 2015 encyclical <u>Laudato</u> <u>Si'</u> (subtitled on Care for Our Common Home), which called upon all of us to 'hear the cry of the earth and the cry of the poor'. The Platform aims to empower individuals and organisations to take 'decisive action, here and now' for a better future.

One of the seven Laudato Si' goals is 'ecological economics'. This goal calls on Catholic institutions to divest assets from ecological injustice and make positive impact investments towards a sustainable future.

FaithInvest has been asked to house the Laudato Si' Investor Hub (sneak preview shown above), providing resources and inspiring case studies. We anticipate that these resources will be of interest to all faiths as they seek to align their values and investments.

The Hub's official launch takes place during the afternoon of our Global Investment Forum event on May 26. It is co-hosted by FaithInvest with AMRI, An Tairseach Organic Farm and Ecology Centre, the Laudato Si' Movement, Laudato Si' Action Platform and USIG JPIC Commission, and will be broadcast on Zoom.
